QUALIFICATION REQUIREMENT

- a) The bidder should have completed Erection, Testing and commissioning of HT / LT Electrical works consisting of HT Transformer of minimum rating 90 MVA and other related Electrical works like HT bus ducts, HT switch gear , cabling trays , etc., during last seven years. The bidder should possess valid licence for High Voltage Electrical Installation.
- b) The bidders should have a minimum average financial turn over of Rs. **47 Lakhs** per year in the preceding three financial years ending 31st March 2009.

The Bidder must have earned profit in any one of the last three financial years ending 31.03.2009 and should have positive net worth as on 31.03.2009.

Bidder should submit audited balance sheet and profit & loss account of the company along with all annexures for last three years ending 31.03.2009 in support of above requirement.
