#### **QUALIFICATION REQUIREMENT**

- A.** The Bidder should have executed a material handling contract ( receipt , unloading, stacking , verification, preservation) of 30% of the estimated weight of materials to be handled ( in the current tender) in a single work order, in any industry.

And

Handling , unloading and stacking of at least one ODC consignment of 100 MT in the same or different work order.

( Or )

- B.** The bidder should have executed erection, testing and commissioning of Boiler of one unit of minimum capacity 60 MW.

Note : "Executed" means Boiler should have been lighted up

( Or )

- C.** The bidder should have executed erection, testing and commissioning of Steam Turbine Generator of one unit of minimum capacity 60 MW

Note : "Executed " means the STG should have been synchronized

- D.** The bidders should have a minimum average financial turn over of **Rs.15 Lakhs** in the preceding three years ending 31<sup>st</sup> March 2009.

The bidder must have earned profit in any one of the last three financial years ending 31.03.2009 and should have positive net worth as on 31.03.2009.

Bidder should submit audited balance sheet and profit & loss account of the company for last three years ending 31.03.2009 in support of above requirement.

BHEL reserves the right to reject any Tender / Bidder , without assigning any further reasons or notice to the bidder, who has been put " on Hold" / or banned from Business dealings with BHEL by any Power Sector Region of BHEL.
