QUALIFICATION REQUIREMENT

A)The bidder should have completed Erection, testing and commissioning of Electrical works like LT switchgears ,LT busducts control panels, cabling (Power / Control) cable trays and other related works in a Power plant (Utility / CPP- coal based or gas based) of minimum unit rating of 100 MW in the last seven years. The bidder should possess valid Electrical installation licence.

“Energisation of the respective equipment will be considered as completion of the works.

- b) The bidders should have a minimum average financial turn over of Rs. **110 Lakhs** in the preceding three financial years ending 31st March 2009.

The Bidder must have earned profit in any one of the last three financial years ending 31.03.2009 and should have positive net worth as on 31.03.2009.

Bidder should submit audited balance sheet and profit & loss account of the company along with all annexures for last three years ending 31.03.2009 in support of above requirement.

- c) Notwithstanding the above, BHEL reserves the right to reject any Tender or all the Tenders for reasons whatsoever beyond our control and the decision of BHEL is final.
